




### What is PPC?







# NO. OF INTERNET USERS WORLDWIDE (IN BILLIONS)



# AGREEMENT

AGREED TO \_\_\_\_\_

DATE \_\_\_\_\_

This website development services agreement is intended as a legally binding agreement between web beveloper and client, collectively known as the "parties". client has agreed to allow the developer to create, develop, test, and host a website according to the - scope of work. Developer is interested in undertaking such work; and client and developer mutually desire to set and agree to the following terms and conditions as listed.

### scope of work

The specific deliverables and project requirements shall be governed by the 'scope of work' document which shall be reviewed and approved by the parties as a document separate from this website development services agreement.

### **Developer** Requirements

client hereby retains the services of peveloper to design, develop and host a website and necessary additional items as listed in accordance with the proposal submitted by developer to client and accepted. changes to this Agreement or to any deliverables in this contract must be published on developer's website and will be automatically accepted to both parties. Agreement will be valid for next 363 days, peveloper agrees to notify company if any risks or schedule delays may take place affecting delivery dates and presentation of the final website. peveloper agrees to personally present said website after 3 to 5 weeks in online meeting for final approval and acceptance by client. client shall provide peveloper with appropriate space and resources for such presentation to take place. peveloper shall provide all necessary computers and staff to effectively achieve such presentation.

### Domain

In case, pricing vary with TLD type or name value, final invoice will vary. Developer will have full control over the DNS of the domain and developer will not resell or migrate domain without consent of client. All rights of domain name belong to the client. In case, agreement or services are prematurely terminated, in that case, the developer will surrender the control and start the process of domain transfer to the client in seven business days.

### web Hosting

Developer shall provide website hosting services for the client's website once development is complete. Hosting shall be a shared hosting environment with a minimum of 99.9% server uptime. Developer is in agreement to maintain a copy of the client's website on an offline server as a backup to the live site. Any and all modifications are expected to be completed within 14 business days of developers' acknowledgment depending on the level of repair or maintenance request. Developer will not give access/source files to any parties authorized by the client for purposes of website audits, updates, or modifications as this may damage the files of website.

### Design

peveloper agrees to attain text approval from the client prior to beginning development by submitting .doc file to the client. client's website will not include any of the following unless previously agreed upon between both parties.

- Any destructive, crude, insulting, harassing, violent, sexual, or any other inappropriate material
- Any and invisible fields or pages.

All materials to be supplied by client must be provided with compatible file types and sizes. Until final approval, no portions of the above site will be made available to end users. The beveloper agrees they shall maintain website backups and one set of the final materials provided for a term up to one year. If this agreement is terminated prematurely or after the agreed backup term, beveloper will destroy any and all copies, files, and documents related to this website development services agreement. beveloper will provide text and image files only (as executable files), besign files are non-transferrable, client has to re-design his/her website from another developer, if he wants to migrate in future.

# AGREEMENT

### updates

client has to submit information (which client wants to update on website) in proper text format. updates are limited to few pages only at extra rates. All social media handles will be setup once by developer and total control will be handover to the client. After that, client will manage social media channels.

### **Digital Marketing**

paid bigital marketing like Facebook ads or voutube ads or any other paid ads are not included in the plan. Ads managements is done on 10% commission-basis.

### change in specifications

The client may request that changes be made to the specifications outlined on 'scope of work', or other aspects of the Agreement and tasks associated thereto. If the client requests such a change, the besigner will use its best efforts to implement the requested changes at additional expense to the client and with or without delaying delivery of the website.

### pricing

This website development services agreement shall be invoiced on a time-and-materials basis. Basic pricing will be the same for the next upcoming years. The beveloper shall deliver an invoice every year or month which details all services and additional costs that the client is responsible for. client agrees to pay each invoice within 30 days of receipt from the beveloper.

### τermination

client may terminate this website development services agreement at any time by providing written notice via email or certified mail to the peveloper. peveloper may cancel this agreement in the same manner if necessary. In the event that this website development services agreement is cancelled by either party, the peveloper shall issue a final invoice for any unbilled services or materials. The client agrees to pay the final invoice according to the terms of this website development services agreement.

### **Refund Policy**

In case, the client terminates the process of website or digital services in the first 15 days or after the project starts up, the developer will not pay any amount in return to the client as the developer has already invested his time and client's money.

If, developer is unable to provide a running website or wants to terminate the project in between the said term (1 vear), then the developer will pay from his fees (fees (in ₹) – (fees/12 mo.) ₹ (No. of months developer had provided service) = xyz₹} where xyz amount will be calculated at month end.

### conflict resolution

This website development services agreement shall be governed by the prevailing laws of Haryana, India. If any conflicts arise related to this agreement, the parties agree to seek a suitable resolution through a neutral arbitrator, whose ruling shall be considered final and binding on both parties.

### Acceptance

The client hereby enters into a binding website development services agreement with web developer, if he/she purchases or renew any of our web design pack.
